MUSEU DE ARTE MODERNA DE SÃO PAULO (“MAM” ou “Museu”), pessoa jurídica de direito privado constituída na forma de associação sem fins lucrativos, com sede em São Paulo, Estado de São Paulo, na Avenida Pedro Álvares Cabral, nº 350, Portão 03, Parque do Ibirapuera, CEP 04094-000, inscrita no CNPJ/ME sob o nº 62.520.218/0001-24, vem, respeitosamente, perante este ilustre Tribunal, apresentar esclarecimentos, em atenção ao despacho do Excelentíssimo Senhor Conselheiro João Antonio, acerca da prestação de contas da Subvenção referente ao exercício de 2024, conforme solicitado no Ofício SSG nº 17554/2024 - Processo nº 6025.2024/0001872-3.

Em atenção ao Ofício supramencionado e ao relatório de análise de Subvenção apresentado, que questiona a aquisição de bens com recursos da subvenção, informamos que, conforme o Plano de Trabalho aprovado, os recursos foram destinados à reforma da telefonia do MAM, incluindo a substituição de aparelhos antigos que vinham inviabilizando as atividades cotidianas da instituição.

Com o fechamento da sede do MAM por determinação do Poder Público Municipal em decorrência da reforma da Marquise do Parque Ibirapuera, a aquisição de aparelhos telefônicos e fones de ouvidos se mostrou indispensável à continuidade das atividades básicas e primordiais da entidade, uma vez que houve o crescimento



exponencial de comunicações telefônicas e reuniões virtuais, dado que a equipe não se encontra mais reunida no prédio do Museu.

Havendo previsão na Portaria nº 68/2021, referente a Contribuição Municipal, que autoriza a aquisição de equipamentos desde que justificada a sua necessidade para garantir a continuidade das atividades básicas (art. 5º, III), entendemos que deve existir uma padronização nos procedimentos, dado que ambas as concessões são verbas diretas e de natureza semelhante destinadas pela SMC ao MAM.

Ainda, embora o valor total das notas fiscais sejam consideráveis (R\$ 25.900,00 e R\$ 6.959,00), gostaríamos de ressaltar que o valor unitário máximo foi de R\$ 695,00 e que os aparelhos possuem uma vida útil curta, que entendemos ser inferior a dois anos, de modo que deveriam ser tratados como bens não permanentes.

Pelos motivos aqui elencados, solicitamos gentilmente que as referidas despesas sejam aceitas.

Permanecemos à disposição para prestar quaisquer outros esclarecimentos que se fizerem necessários.

Nesta oportunidade renovamos os votos de elevada estima e distinta consideração.

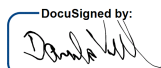

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, MAM (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

To request paper copies from MAM

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to mamjuridico@mam.org.br and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with MAM

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;

ii. send us an email to mamjuridico@mam.org.br and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

Required hardware and software
